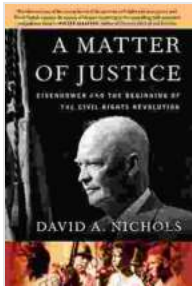

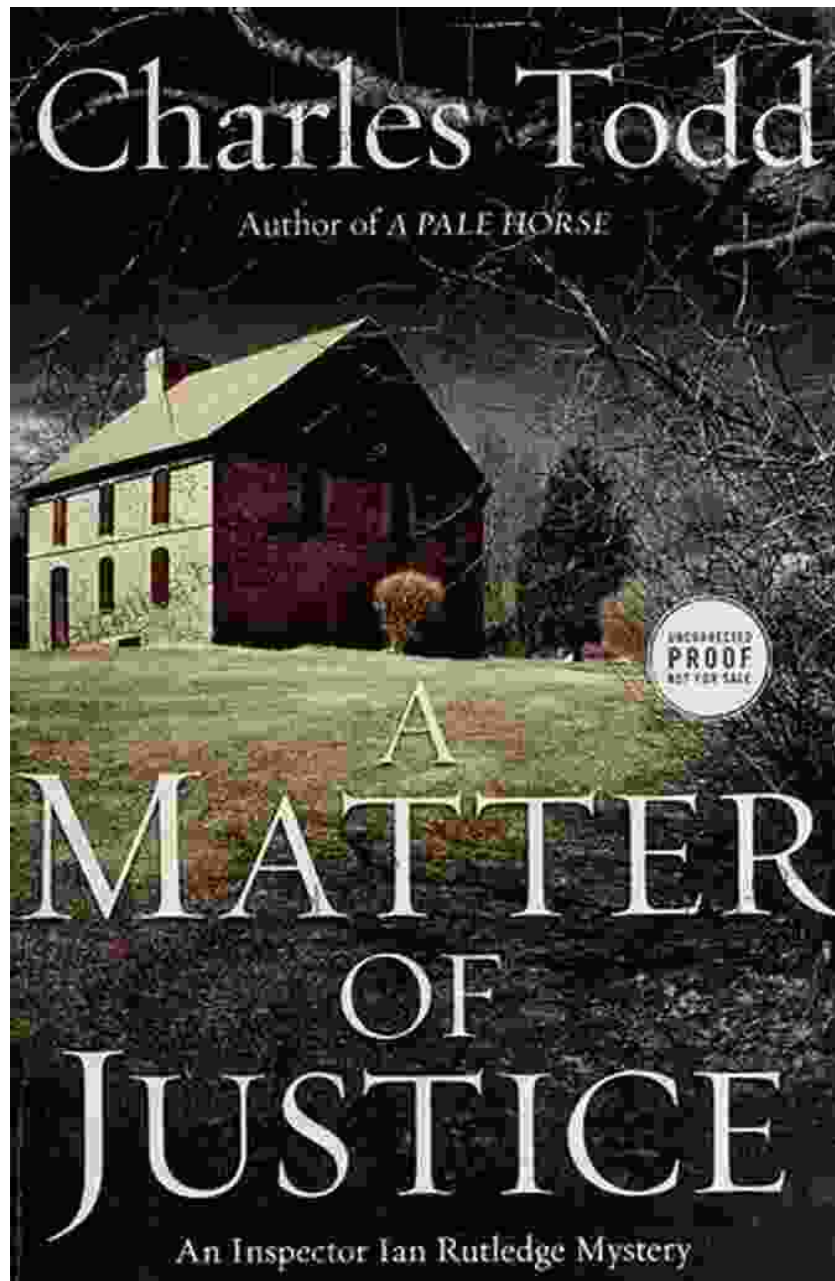

Grisham is a generous supporter of many charities, including the Innocence Project and the Save the Children Fund. He and his wife, Renee, live in Oxford, Mississippi.

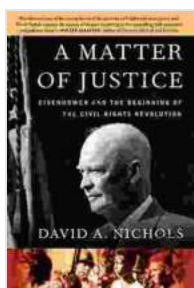
